

School of International Business

Principal's Statement

The School of International Business (SIB) at the Kearny High Educational Complex emerged to improve learning opportunities for students. SIB provides instructional support and a purposeful, studentcentered infrastructure to promote academic achievement among all students, including those who have traditionally been under-represented in comprehensive high school settings. The intimate and direct connection between SIB students and the school's community is the unique asset that sets SIB apart from many urban high schools. Consequently, the school's core values and belief system reflect a strong sense of personal growth and local community involvement, along with an awareness of world languages and business practices. The school is committed to providing students with a high quality education in a personalized learning environment. It is uniquely structured to produce innovative, principled, culturally aware, and insightful leaders of business, government, and nonprofit organizations. SIB students acquire the necessary skills to challenge themselves, as the school's slogan suggests, "beyond borders and beyond barriers," in order to make meaningful contributions to their community.

Instruction and Curriculum

The San Diego Unified School District Board of Education has formally adopted California State Board of Education-approved academic standards and curriculum frameworks for all subject areas. District curriculum materials, instructional strategies and supports, professional development, and student assessments are aligned with state standards and focused on ensuring that every student has access to a highquality, rigorous, and engaging instructional program. A range of support opportunities is available for students needing additional assistance.

The School of International Business is committed to the concept of "distributive" leadership. The decision-making structure of the school includes the administration, all staff members, and a representative panel of students, parents, and community members. Teachers meet on regular basis to refine the curriculum and examine instructional practice. Students are provided academic support through tutoring by a credentialed teacher, the Advancement via Individual Determination (AVID) program, and grade-level advisories. SIB is proud of its long-standing partnership with Mesa Community College. Through the dual enrollment program all students have access to a wide variety of college courses. In 2008, all seniors will have completed at least one college class and nearly two-thirds completed nine college units.

Opportunities for Parent Involvement

Parents have many opportunities to be involved at their children's school site (for example, governance committees, special events, fundraising events, parent organizations, and in classrooms) and at the district level (for example, district councils/committees, Parent University, and special events). We also encourage parents to support their children at home by making their expectations about school clear and creating a positive homework and learning environment.

We at Kearny International Business are committed to obtaining community resources for our school and invite all constituencies to assist us in the education of our students.

The SIB governance board, comprising staff, students, and parents, serves as a liaison between the community and administration, advocating for innovate methods of communication such as the on-line ParentConnection application, homework update line, and Grade Night, where parents receive their child's progress grades and all teachers are available to confer about the student's academic progress. The English Learner Advisory Committee plays an active role in empowering parents of second-language students.

Academic Performance Index (API)

Standardized Testing and Reporting (STAR) Program

Through the California STAR Program, students in Grades 2–11 are tested annually in various subjects. The California Standards Tests (CST) include English language arts and mathematics (Grades 2–11), grade-level science (Grades 5, 8, and 10), end-of-course science (Grades 9, 10, and 11), and history–social science (Grades 8, 10, and 11). Prior to 2005, the norm-referenced test (NRT) tested reading/language arts and mathematics (Grades 2–11), spelling (Grades 2–8), and science (Grades 9–11). Beginning in 2005, the NRT tests reading/language arts, spelling, and mathematics in Grades 3 and 7 only, and no longer test science in any grade. To protect student privacy, "–" is used in the following tables instead of the percentage when the number of students tested is 10 or less in that category.
