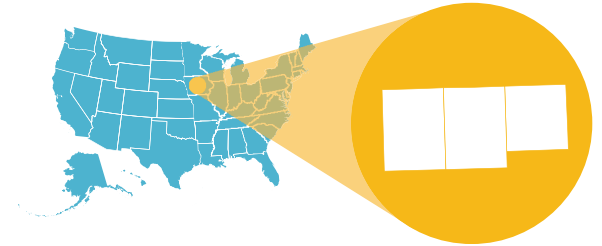

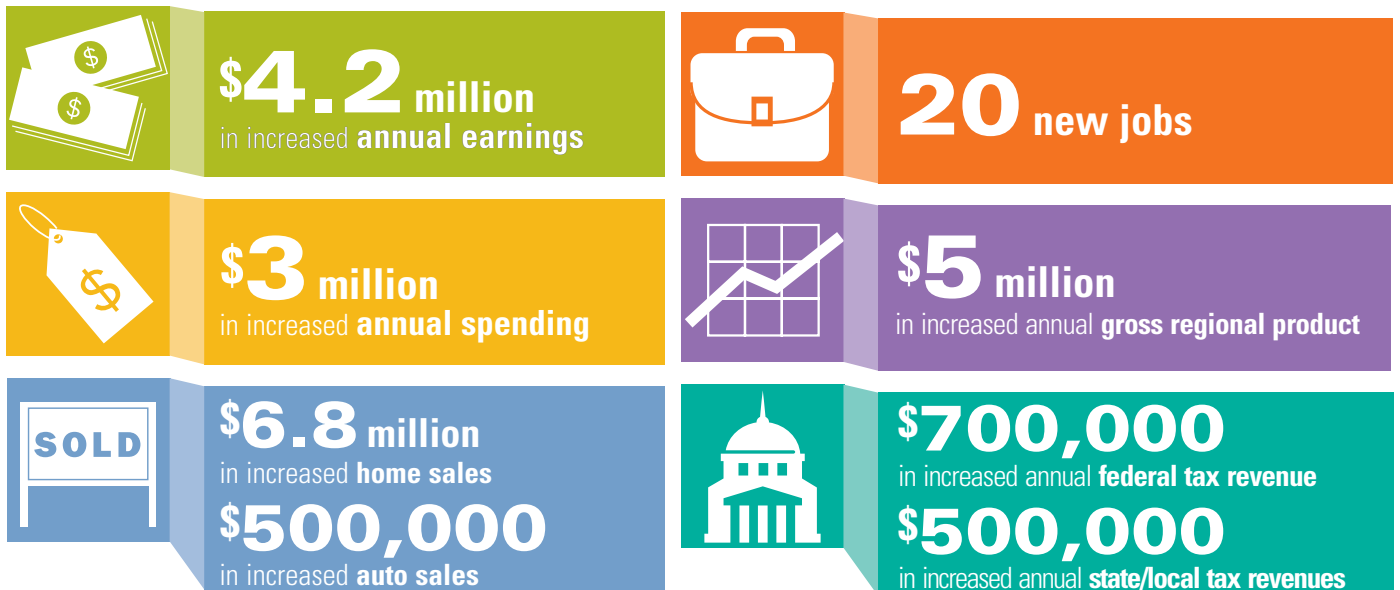
WHAT IF ...
