Republicans and Democrats continue to battle over "supplement, not supplant," an esoteric but important provision in the Every Student Succeeds Act (ESSA) that governs the use of Title I funds. The most recent debate took place during a September 21 hearing held by the House Education and the Workforce Subcommittee on Early Childhood, Elementary, and Secondary Education.

STRENGTHENING CAREER AND TECHNICAL EDUCATION: House-Passed Bill Would Rewrite Perkins Act, Better Align CTE with Twenty-First-Century Jobs

Bipartisan consensus is difficult to achieve—especially with a presidential election right around the corner—but the U.S. House of Representatives did just that on September 13, when it passed the Strengthening Career and Technical Education for the 21st Century Act by a vote of 405–5. The bill rewrites the Carl D. Perkins Career and Technical Education Act (Perkins), which provides more than \$1.1 billion in federal education funds for middle schools, high schools, and postsecondary education.
